PIE: AN UNTAPPED RESOURCE FOR IOWA EMPLOYERS

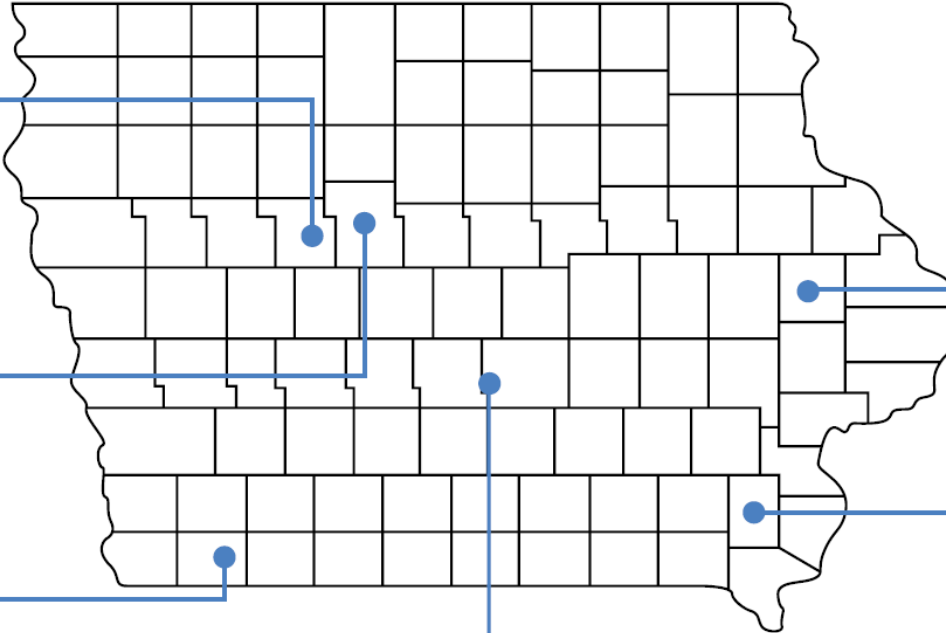
- Created by Congress in 1979 to encourage state and local governments to establish employment opportunities for prisoners

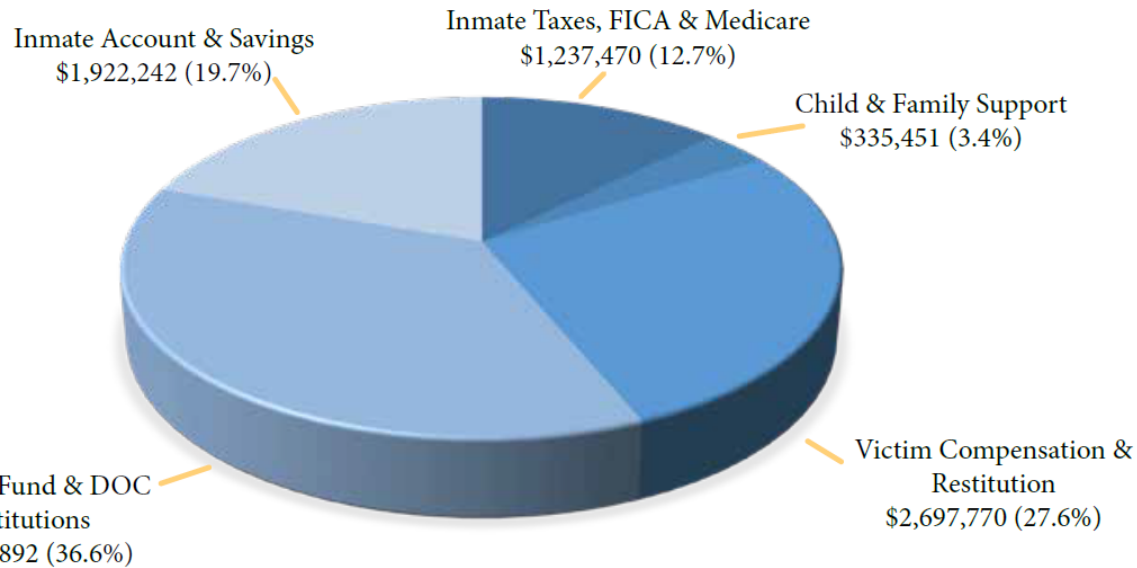
CRITERIA FOR PROGRAM PARTICIPATION

- Pay wages at a rate not less than that paid for similar work in the same locality's private sector
- Written assurances that the program will not result in the displacement of lowan workers
- Legislative authority to collect and provide financial contribution of not less than 5% and not more than 20% of gross wages to crime victim compensation/assistance programs
- Incarcerated Individuals receive 20% of the gross hourly wage they earn
- Written assurances that inmate participation is voluntary
