## I. Call to Order.

Board chair Greg Steggerda called the meeting to order at 10:01 am on September 25th, 2023. Since five board members were present, the board did have a quorum and could conduct business.

Justin Opfer- Mitchellville Plant Manager welcomed the group, shared with them the diverse work being done on site and the sense of pride and excellence exhibited by the staff and II's working there.

# II. Approval of Previous Minutes (March 31st, 2023)

#### III. Review of Sales to General Contractors

Bob Fairfax provided an update by location along with Justin Opfer updating operations at Mitchellville, Central Canteen in Newton, and Ft Dodge. Mr Fairfax elaborated on how IPI is reshaping and remaking itself in the marketplace to accommodate for the loss of furniture sales and operations. Remaking the organization for the future to meet the needs of our customers and operational revenue requirements to remain self funding part of the DOC.

#### VII. Sale of the Farm Ground by Iowa Legislature

Bob Fairfax updated the board, with the legislature decision to sell the farm ground, Mr. Fairfax explained how the process was evolving, working with the Governor's Office and the Department of Administrative Services.
